






#### **Digital Distribution Extends the Potential Impact**

Global Box Office – All Films (US\$ Billions)










#### Transfer Risk & Exposure Demands a Solid Security Program that Combines People, Technology, and Processes






## What's Next? Continuous Investment in the Future

- Deluxe Web Watch<sup>™</sup> watermark and monitoring for secure distribution of screeners
- Forensic watermark technology to protect higher quality 4K and HDR content.
  - 4K and HDR opens door for pirated content in all media types (physical, digital, streamed, download) to be rendered at much higher quality
- Improvements in processing and workflow automation:
  - Offset the need for distributors (i.e. MVPDs) to abstract and manipulate data downstream.
  - Greater auditing and tracking throughout the workflow; providing transparency at every point in the supply chain.
- Expanded use of Virtual Desktops (VDI) to abstract the users from the data.
- Centralized ingest and asset tracking architecture from start through the Deluxe process.
  - Ingest once, prepare and distribute content globally in any format, for any release window and to any device and destination.
