EIDR: 10 Years Strong

- EIDR is a globally-unique, curated identifier system for films & shows
- The EIDR Story
 - The registry went live in December 2010
 - Now over 2.2 million EIDR IDs and 4.5 million Alt IDs
 - Users from well over 100 different countries
 - Over 200 million EIDR API calls per year

 - New digital use cases



EIDR New EIDR 2.5 De-Dupe Platform

- Reliability and resilience for registry & de-dupe
- 100% compatibility with installed base
 - Web UI
 - Command line tools
 - Member integrations using:
 - REST API
 - Java SDK
 - .NET SDK
 - Bulk match/register spreadsheets
- Performance improvement
 - Tested 40 clients submitting 90K match transactions
 - De-Dupe capacity estimate:
 - 6,500 match transactions every 5 minutes
 - 60 simultaneous client submissions
- Member & partner de-dupe coming soon







EIDR 2.5+



- The EIDR 2.5 continuous improvement program
 - EIDR 2.5 was released on April 25
 - First EIDR 2.5+ update was released on May 22
 - Improved automated response for numbered episodes
 - Refined scoring for records with mismatched actor lists
 - Streamlined Alternate ID update process
 - June will be "Edits Month"
 - Performance improvements for automated Edit record de-duplication
 - Our ongoing mission:
 - To increase the accuracy of automated de-duplication
 - To reduce the need for manual review
 - To boldly identify what has not been identified before



EIDR for the Next 10 Years



- EIDR 2.6 and beyond new features built on 2.5 platform
- EIDR 3.0 new registry platform
- Expanded ISAN interoperability
- Key growth areas digital platforms
 - NENT/Viaplay
 - Registers all content on the platform
 - Key content management and automation component
