



Avg time patients spend viewing content in Mytonomy



Healthcare Breach Trends for 2020

Ransomware

- Blackbaud breach impacted multiple healthcare organizations
 - Trinity Health portion of Blackbaud's breach alone 3.3 million individuals
 - Breach result of 2 major things 1) Vendor due diligence issue and 2) successful phishing attack
 - Target breach 2014 (70 million records) also rooted in vendor due diligence issues
- 3rd Party Vendor Due Diligence is Critical
 - HHS shows 170 breaches affecting nearly 12.9 million individuals were reported as involving a business associate as of October 2020
 - Employee training, especially as we've moved to home / remote so quickly
 - · Even innocent uses off work computer by home dwellers can compromise security
- Phishing and E-Mail Scams
 - <u>Legacy Community Health Services</u>, employee response to phishing attack exposed >228,000 individuals
 - Employee training needed in most companies to help recognize phishing attack and appropriate response
- Mobile Device Theft
 - Health Share of Oregon, stolen unencrypted laptop, > 654,000 individuals exposed

Data Breach Today: <u>Health Data Breaches in 2020: Ransomware Incidents Dominate</u>

Standards Based Approach from Beginning

Mytonomy uses a Governance, Risk and Compliance (GRC) platform to manage multiple standards, identify and document controls, and manage evidence collection for audit and self assessments.

- AICPA SOC 2 Type 2:
 - Trusted, tested processes from company founding
 - Critical vendors required to also have their own SOC 2 Type 2
- NIST CyberSecurity Framework (CSF)
 - Flexible risk-based guidelines tied to sensitivity of data
 - Draws on strong leadership experience with NIST 800-53, FedRAMP, FISMA
- Cloud Security Alliance Cloud Controls Matrix
 - Mapping multiple requirements to high level controls for cloud services


Identify & Implement Relevant Controls

- HIPAA as amended
 - Risk Based Controls drawn from NIST 800-66R1, NIST 800-53R4
 - Addressable vs. Required (example: laptop encryption as "addressable")
- Center for Internet Security Benchmarks
 - Consensus configuration controls driven by real world security risk
- Open Web Application Security Project (OWASP) Top 10 Web Application Security Risks
 - Specific best practice configurations for application security risks

Mytonomy's Security Future

- Moving Toward <u>Zero Trust</u> in Secure Access Service Edge (SASE) Environment
- Formal NIST CSF Implementation
- Upgrading Data Loss Prevention Controls
- Updating Staff Security Awareness and Training with Testing, Internal Phishing Exercises
- Extending Reach of Multifactor Authentication
- Automating Vendor Due Diligence in GRC Platform

Healthcare's Future Brighter Than Ever



- Massive innovation coming in healthcare, and with that success security and appropriate controls are needed more than ever before
- Tons of innovation coming that uses content, user data and integrates in novel ways:
 - Home Lab Testing (My FDA EIR work with Tricorder)
 - Patient PHI, content, data
 - Life Extension
 - Disease Extension cell / gene therapies
 - Protecting R/D and Supply of innovative devices and therapies
 - COVID Vaccine coming first dose today to Sister (Woman of Northern Irish descent in the UK)
 - Hospital to Home, Telehealth, Asynchronous Virtual Care – engaging patients in novel ways, OTT streaming is just one.
 - Virtual / Augmented Reality, XR platforms to enable new ways of learning and meeting in the clinical workflow
